#### **Matter for Decision**

**Ward Affected:** Neath North

#### **Proposed Prohibition of Waiting at Any Time Order – Ridgewood Gardens, Neath**

#### **Purpose of Report**

1. To consider the objections received following the advertisement of the proposals as indicated in Appendix C.

#### **Executive Summary**

2. One letter of objection was received in respect of the proposal. The report outlines the objection and the recommendation for the scheme.

#### **Background**

3. In March 2016, a proposal was considered by the Board (Appendix A) following an objection. The Board upheld the objection and a revised scheme advertised. At the same time, a consultation exercise was undertaken to all properties directly affected by the scheme (Appendix B).

#### **Financial Implications**

4. The work will be funded by the Capital Works Programme.

## **Equality Impact Assessment**

5. A Screening Assessment has been undertaken to assist the Council in discharging its Public Sector Equality Duty under the Equality Act 2010.
6. After completing the assessment it has been determined that this function does not require an Equality Impact Assessment.

8. The scheme has been advertised for a 21 day period.

11. As part of the consultation exercise a letter-drop was undertaken to all residents within the immediate vicinity of the proposals. During the consultation process one letter was received in respect of the proposal.

12. Letter 1:-

The objector claims they and their visitors will still not be able to park outside their property and wants all the parking restrictions removed as the objector believes they are ineffective.

## **Recommendation(s)**

13. It is recommended that:-

The objection be overruled and the objectors informed accordingly, and the scheme be implemented as previously advertised.

## **Reasons for Proposed Decision**

14. The scheme is necessary to prevent indiscriminate parking within 10 metres of the junction in the interest of public safety and as stated in the Highway Code.

## **Implementation of Decision**

15. The decision is proposed for implementation after the three-days call-in period.

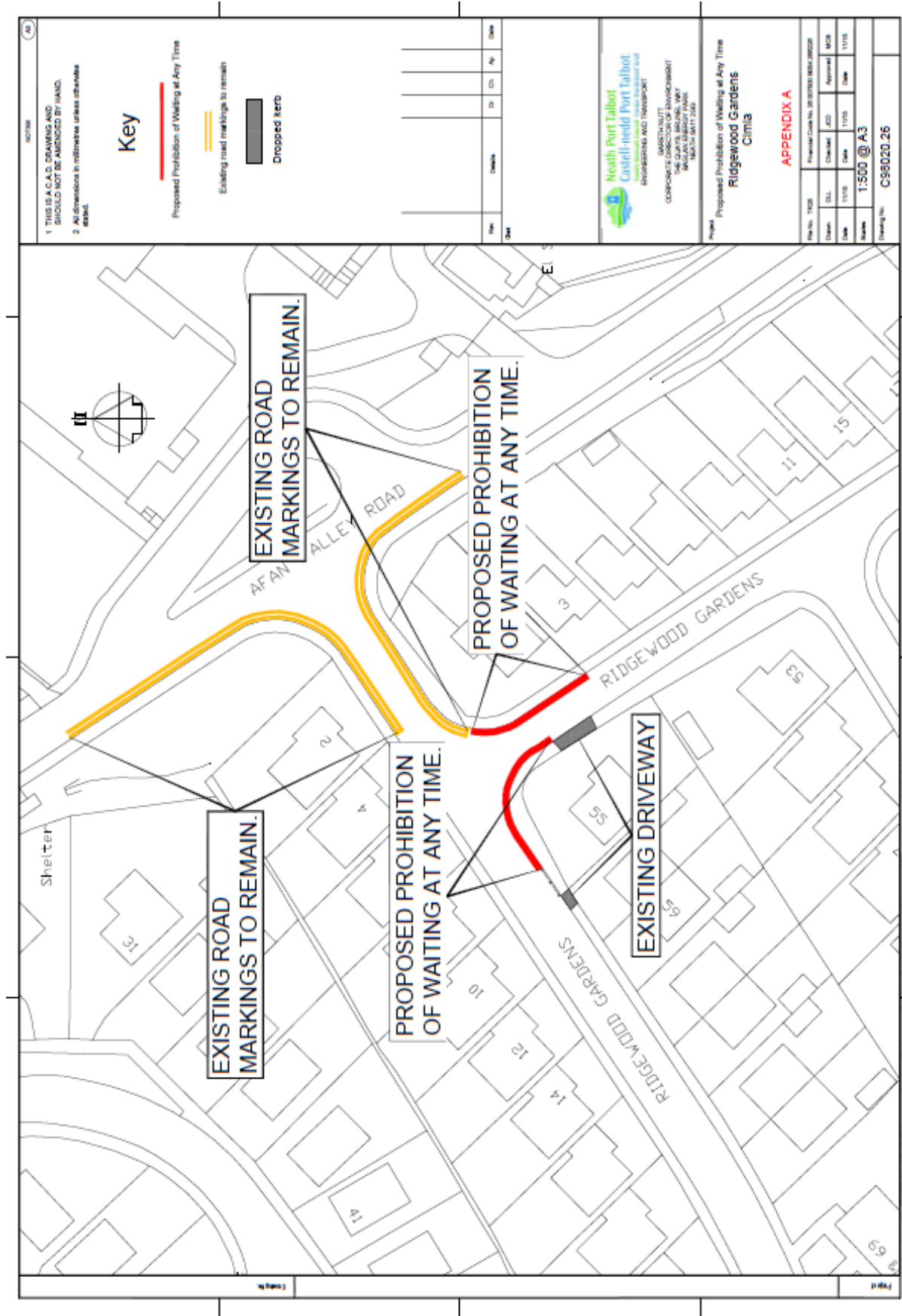

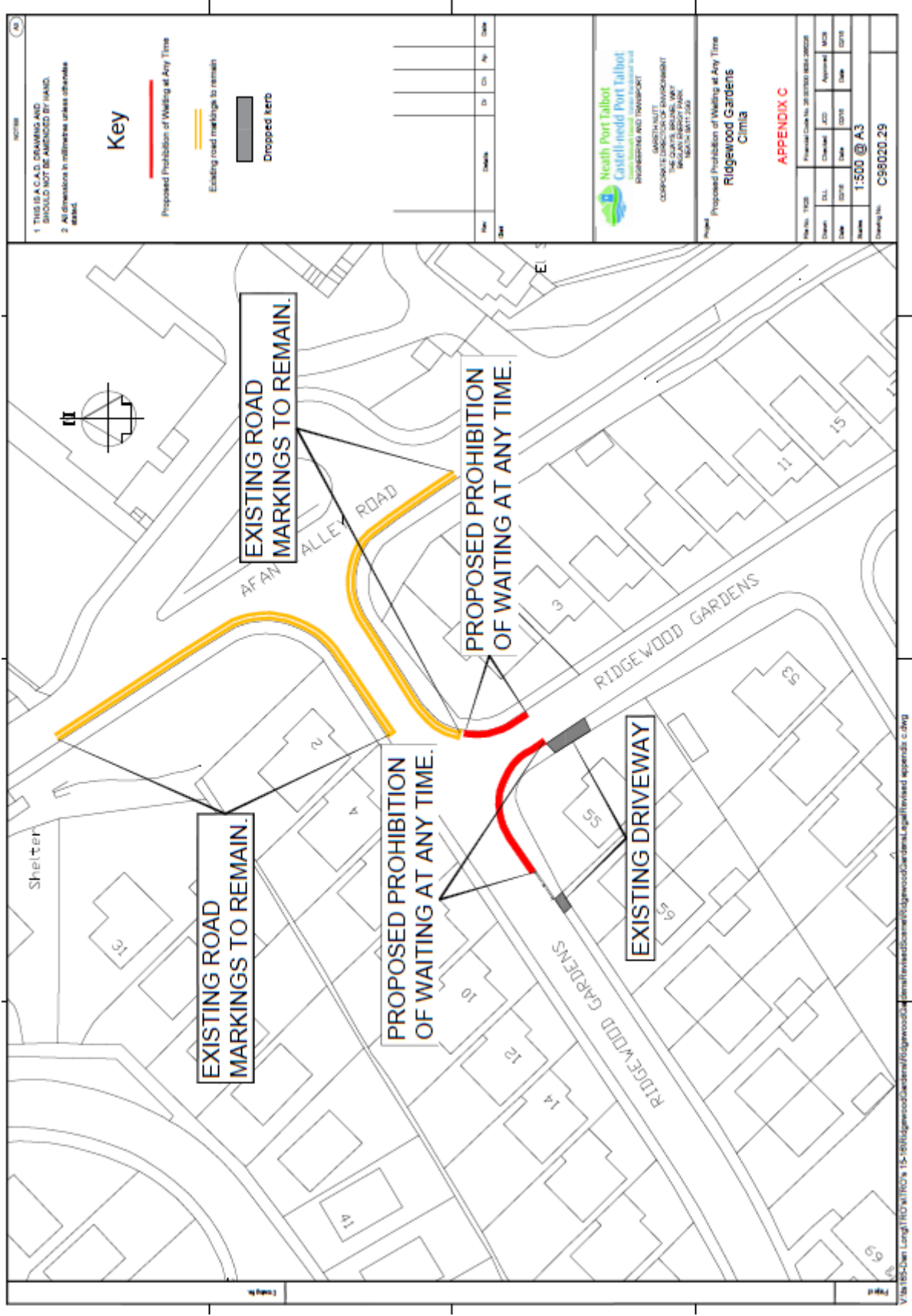
