Matter for Decision

Harold & Joyce Charles Trust Fund

1. Purpose of the Report

To seek approval for the administrative arrangements relating to the Trust.

2. Executive Summary

The will of the late Joyce Charles stated that the residue of her estate be left to the former West Glamorgan County Council, to be placed in a Trust Fund entitled the Harold & Joyce Charles Trust, the purpose of which is to assist students in gaining further Degrees.

A Trust deed was prepared following consultation with officers in both Neath Port Talbot and the City & County of Swansea, which was signed in November 2015, outlining the purpose of the Fund and rules governing the award of grants to recipients.

The Charitable Trust Deed identifies Neath Port Talbot County Borough Council as Trustee to the Fund and responsible for managing its financial affairs.

The net proceeds of the estate (£437,957.51) were received by the Council in December 2015.

This report outlines the proposed arrangements for administration in accordance with the rules of the Trust Deed.

3. Background

The object of the Trust is the advancement of education of graduate students, so they may gain a further degree qualification for the benefit

of the public generally, by the payment of grants to individuals in accordance with the rules of the Trust.

The rules require that the grant monies available for allocation are divided pro rata to the population of the two Authorities as at the date of the Trust Deed (17th November 2015).

Based on population as at that date the fund will be split as follows:-

The Trust will be administered by this Council, but with separate records being maintained to record the transactions relating to each Authority.

4. Application process

Applications will be invited from residents of the area of benefit i.e. the geographic area administered by both Councils

Residents are defined as:-

- persons resident during term time only (i.e. students at institutions in the area
- persons residents outside of term time only (i.e. students attending institutions outside the area)
- graduates normally resident in the area

A notice will be placed on the website of each Local Authority, and letters written to the establishments providing further degree courses in the area, in March each year. The fund will open for applications from 1st April and close on 31st May each year.

Electronic versions of the application form will be available to facilitate on line applications. (Appendix 1)

In order to be eligible to receive funding students must be:-

- resident in the area (as outlined above)
- undertaking a further degree
- not be in receipt of funding from any other awarding body

5. Calculation of award

Applications will be reviewed by NPT officers and a list of eligible applicants prepared

The amount available for allocation will be based on the total interest earned in the previous financial year.

A meeting of officers from each Authority will be held annually to review the proposed awards, which will then be reported to Policy &Resources Cabinet Board for formal approval. It is proposed that the meeting of the Cabinet Board which considers other Education Trust Fund grant awards will be used for this purpose.

Successful applicants will be notified, and payments made at the start of the academic term.

6. Implementation

It is proposed that application for grant from the Trust Fund will be available for eligible students from September 2018.

7. Financial Impact

The fund will be administered as a separate fund and hence there will be no financial impact on the Council.

The Accumulated fund balance as at 31st March 2017 reported in the Annual Report for 2016/17 was £439,791. (Appendix 2)

The rules of the fund allow the cost of staff time incurred in administering the fund to be recharged to the fund.

8. Equality Impact Assessment

The Equality Act 2010 requires public bodies to pay due regard to the need to:

- eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Act;
- advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- foster good relations between persons who share a relevant protected characteristics and persons who do not share it."

It is not anticipated that any particular group with protected characteristic are disproportionately affected by the proposal, from those eligible to apply for a grant.

The equality impact of the proposal is therefore considered to be neutral.

9. Workforce Impact

It is anticipated that the administration of the fund can be absorbed by the existing workforce.

The main impact will be on the Student Support Service team who will be responsible for coordinating the application and award process, and the Financial Services team who will ensure appropriate financial arrangements are in place to fulfil the requirements for the Council, as Trustee of the Fund.

The administrative processes proposed are based on the existing arrangements already in place for the administration of the Glamorgan Education Trust Fund.

10. Legal Impacts

As Trustee this Council has control of the Trust and its property and funds, in accordance with the objects and rules laid out in the Trust Deed.

The Trustee must comply with the requirements of the Charities Act 2011 relating to the keeping of financial records, the audit or independent examination of accounts, and the submission of returns to the Charity Commission.

11. Consultation

This item has been has been subject to external consultation with the City and Council of Swansea, in accordance with the requirements of the Trust Deed.

There is no requirement for the matter to be subject to public consultation.

12. Recommendation

That the Cabinet Board authorises the Director of Finance and the Director of Education to administer the Fund in accordance with the objects and rules outlined in the Trust Deed and make available for grant application for September 2018.

13. Reasons for Proposed Decision

To administer the fund in accordance with the Trust Deed.

14. Implementation of Decision

The decision is proposed for implementation after the three day call in period.

The Harold & Joyce Charles Trust Fund was established by a trust deed dated 17^{th} November 2015.

Harold & Joyce Charles Trust fund

The Harold & Joyce Charles Trust Fund was established to assist students in gaining further degrees.

Aims and Objectives

The objective of the Trust is the advancement of the education of graduate students so they may gain a further degree qualification, for the benefit of the public generally and the residents of the area of benefit.

Where

- Residents includes graduates normally resident in the area, persons resident during term time only (students attending institutions in the area), and persons resident outside of term time (students attending institutions outside the area)
- Area of benefit refers to the geographic area administered by Neath Port Talbot CBC and the City & County of Swansea

The rules of the fund state that the Trustees

- Have powers to raise funds by any means except taxable trading
- Must use the income, and may use the capital, in promoting the objective of the Trust.

Review of Financial Activities.

The Trustee has power, in consultation with the City & County of Swansea to make regulations consistent with the deed, to govern the use and application of the property and funds of the Trust, including regulations about the operation of bank accounts and the commitment of funds.

A draft proposal is currently being prepared for approval by the two Authorities, outlining the basis on which the fund will be invested and administered, in accordance with the objects and rules relating to the award of grants.

The cash balance at 1st April 2016 was £436,885, interest of £3,066 was received, and expenditure of £160 on legal fees relating to the original transfer of the estate to the Council was incurred, resulting in a cash balance of £439,791 at 31st March 2017.
