2. <u>MINUTES OF THE PREVIOUS MEETING HELD ON 10 MARCH,</u> 2017

RESOLVED: that the report be noted.

4. <u>GRANT OF DISPENSATIONS AND RENEWAL OF GRANTS</u> <u>UNDER SECTION 81(4) OF THE LOCAL GOVERNMENT ACT 2000</u>

(At this point in the meeting Councillor S.Freeguard and Mr C.Jones reaffirm their interests in this item and leave the meeting for the discussion and voting – Resolution 4 (a) below)

Members considered renewals and applications received for Employment Dispensations, Miscellaneous Dispensations, Dispensations regarding School Governors, Standard Dispensations for School Reorganisation and Dispensations for Voluntary Sector Funding, as detailed in the circulated report.

The Head of Legal Services and Monitoring Officer explained that an extra request for dispensation in the categories of Employment and School Reorganisation Dispensations had been received from Councillor Rob Jones (Leader of the Council) as his daughter had recently been employed as a teaching assistant at Ysgol Maes Y Coed. Members approved the grant of the additional Dispensations.
