AMENDMENT TO STAFFING STRUCTURE OF HIGHWAYS AND DRAINAGE SECTION

1 Purpose of the Report

The purpose of this report is to seek Members approve to create four Streetcare Driving Skilled Operatives (Non HGV) posts (Grade 4 – JEID2996) with effect from 1st April 2018 and delete four Roadworkers (Grade 3) posts. All posts are within the Drainage and Highways Section of the Environment Directorate.

2 Background

There are four Roadworkers (Grade 3) with the teams that deal with reactive highway and drainage repairs. The employees were previously Modern Apprentices and are now fully trained and experienced. Given their skills they are now regularly undertaking more skilled roles and acting up.

To protect the Council's investment and improve operational flexibility it is now proposed that the four roadworker posts be deleted and the four employees occupying these posts be offered suitable alternative employment as Driving Skilled Operatives (Non HGV) (Grade 4). This will utilise the skills they have learned during their employment whilst also contributing to flexibility and service delivery. Existing and Proposed structures are shown in Appendix A.
