#### NPTCBC STANDARDS COMMITTEE - COMPOSITION OF ADVISORY PANEL FOR RECRUITMENT OF INDEPENDENT MEMBERS

### **Purpose of the Report**

 To obtain approval for the composition of the advisory panel to consider applications to become Independent Members of the Standards Committee following amendments since the 21<sup>st</sup> February 2018..

## Background

- On the 21<sup>st</sup> February 2018, a report was brought to Council for approval for an advisory panel to interview candidates for appointment as Independent Members to the Standards Committee to be set up which was to be constituted as follows:
  - County Borough Council Members The Mayor and Councillor Del Morgan
  - Lay Member Ms Gaynor Richards
  - Standards Committee Ms Julie Howells Vice Chair of Standards Committee and a further member of Standards Committee drawn from the remaining independent members.

- 3. The Standards Committee met on the 16<sup>th</sup> March 2018 and subsequently confirmed that the further member should be Mr Cliff Jones.
- 4. Since that date, due to availability of members of the Selection Panel and the need to hold the Selection Panel Meeting on the 8<sup>th</sup> May 2018 and 29<sup>th</sup> May 2018, it was suggested that Councillor Alun Llewellyn should sit on the advisory panel in the place of Councillor Del Morgan.
- 5. Advertisement has been undertaken for appointment of Independent Members and the panel will now convene in May 2018 to consider applications and to make a recommendation to Council of appointment of Independent Members.
