CSG231: Investigation under section 71 of the Welsh Language (Wales) Measure 2011 of a possible failure to comply with Welsh language standards

Please find enclosed the final report and decision notice of this investigation into Neath Port Talbot County Borough Council's compliance with standard 60 in relation to a parking ticket machine, located at the Harbourside, parkway, Port Talbot.

I have had due regard to representations made by the Council on the proposed report. The Council is questioning the Commissioner's interpretation of standard 60. It is alleged that the Commissioner implies a distinction to the different operational stages of the self service machine, and that standard 60 or paragraph 39 of the Regulations do not draw such distinctions. The Commissioner considers that it is important to recognize the steps taken to enable the self service machine to be implemented up to the point where a Welsh language service is offered to ensure compliance with standard 60. Following a meeting with the Council to discuss the way forward, the investigation's enforcement action has been adapted.

You have the right to appeal against my decision and enforcement action. Further information about the appeals process is provided in the enclosed leaflet, and on the Welsh Language Tribunal's website.
