#### **REASONS**

The Joint Scrutiny Committee have asked to be provided with the the current webcasting arrangements in each host authority and to consider the costs associated with deciding to webcast its meetings in future.

## **Pembrokeshire**

Facilities are available in both the Council Chamber and the Committee Rooms.

Cost of Webcasting operator - £41.50 per hour

Cost per hour of webcast- £128.50

Total cost per hour- £170.00.

Total cost per meeting (average 5 hours)- £ 850.00




















Each host authority will hold a maximum of 2 meetings at its location a year.

Total maximum cost = £1,700

- After meeting archiving recording)

#### Camarthenshire

Facilities are available in the Council Chamber.

Cost per hour of webcast- £120.00

Total cost per meeting (average 5 hours) - £ 600.00

Each host authority will hold a maximum of 2 meetings at its location a year.

Total maximum cost = £1,200




















## Swansea

Facilities are available in the Council Chamber.

Total cost- negotiable/possibly Free of Charge depending on the requirements (i.e. frequency and length of meetings) as could be incorporated into the existing contract.

### **Neath Port Talbot**

Neath Port Talbot do not currently have webcasting arrangements for their meetings. In order to do so they would need to buy in a service.

Early estimated costs are circa £2,000 per meeting.

Each host authority will hold a maximum of 2 meetings at its location a year.

Total maximum cost = £4,000

Total estimated annual costs for webcasting Scrutiny Committee meetings

= £6,900
