## **Impact Assessment - First Stage**

#### 1. Details of the initiative

**Initiative description and summary:** The Civic Square area is in a prominent location between the Princess Royal Theatre, Port Talbot Civic Centre and the Aberavon Shopping Centre. The area is currently paved with a fountain and raised plant beds at its centre, which is outdated and serves no purpose at this key location. The proposed scheme will include replacing the existing surface materials with new, more modern, durable and attractive materials.

The scheme will also provide electric power supply units within the repaved area that can be used to accommodate events such as markets and special events that would otherwise rely on generators. This ease of access to a power supply could result in events such as Christmas parades, Summer carnivals, seasonal markets and even ice rinks and an outdoor cinema using the easily accessible space. New street furniture including seating and bins will also be provided to encourage the area to be used as a communal space within the town centre.

This refurbishment scheme will provide a focal point of the town centre and an area of outdoor amenity space that will be heavily used by locals and visitors to the town.

The project aims to support our local businesses by increasing footfall in our town centre, making it a more attractive place in which to live, travel, work and enjoy recreational time.
