### **Impact Assessment - First Stage**

#### 1. Details of the initiative

**Initiative description and summary:** The Riverside area in Port Talbot town centre stretches from outside the Post Office building at the top end of Station Road to the banks of the River Afan up to the Carmel Church. The area is currently a riverside garden that is underutilised and not aesthetically appealing. The proposed redevelopment of the area will include a combination of hard and soft landscaping along with a children's play area. Opening the area up and providing additional street furniture will create a welcoming space for residents and visitors to enjoy.

The recent completion of a number of housing led schemes in the town centre has resulted in the number of residential units increasing substantially. Despite the increase in the numbers of people living within the town centre, there is no children's play area provision within close proximity. This open area provides a perfect location to provide a range of play equipment with safety surfacing and a boundary fence for the children's safety.

The landscaping of the site would include hard and soft landscaping such as new paving and tree and shrub planting. This scheme will provide a much needed improvement to the appeal of the area that is in a key location between the main shopping street in Port Talbot and the Aberavon Shopping Centre.

The project aims to support our local businesses by increasing footfall in our town centre, making it a more attractive place in which to live, travel, work and enjoy recreational time.
