<b>1c</b>	<b>Summary of the initiative:</b> To inform Members that the Head of Adult Services intends to enter into a grant agreement with Neath Port Talbot Carers Service (“the Carers Service”), for the delivery of short break respite provision to unpaid carers (“Carers”).

<b>1e</b>	<b>Who will be directly affected by this initiative?</b> Unpaid carers
<b>1f</b>	<b>When and how were people consulted?</b> As part of developing the proposal for utilising this Fund, the Carers Service sought feedback from Carers on what would make a difference to them. The feedback from this included:

- Short Breaks Caravan/Cottage
- Spa Treatment
- Nail Vouchers
- Coffee Shop/Meal Vouchers
- Gym session
- Wellbeing Activity/Event
- Yoga Sessions
- Walking Groups
- Night Away in a reasonable priced accommodation
- Night Away to themselves,

The Carers Service is asked to obtain service user feedback in order to inform the delivery and performance of the service. The Carers Service provide reports to the Council on what participation events have taken place and how the feedback from Carers has shaped their services. This feedback indicates that Carers appreciate the provision of events and activities and benefit from the provision of respite services.

A significant amount of engagement and consultation took place in the development of the Regional Carers Strategy. This identified that the below areas were of key importance to Carers, all of which this proposal will support:

- Peer support.
- Community based support.
- Better range and quality of services to meet Carers needs for a break.
- More flexibility and choice.
- More opportunities to take a break.
- More support for Carers to access social and leisure opportunities.

Furthermore, the consultation process that took place between 17th June 2019 and 15th September 2019, highlighted that Carers wished to have more flexible options for respite, including alternatives to traditional residential respite.

**1g What were the outcomes of the consultation?**

The proposed activities, short breaks and vouchers are all based on this feedback.

## 2. Evidence

### What evidence was used in assessing the initiative?

Social Services routinely collects data as part of the assessment/review process of individuals and carers, which is reported annually to Welsh Government.

In addition to the number of people accessing services, limited equalities data such as age, disability, ethnicity and sex is also collected, which in turn informs policy development and service provision. The following provides a summary of information about carers known to Social Services:

From the tables above it can be seen that two-thirds of the carers which we have information on are female; more than half of carers (54%) are aged 60+ years. Limited ethnicity data shows that the carers' ethnicity is not recorded in 58% of cases.

The vast majority of carers live in Neath or Port Talbot, however there are some who live 'out of county'.

It should be noted that the 441 carers for whom Social Services has details is only a fraction of the more than 20,000 people who have self-identified as carers in Neath Port Talbot at the time of the last Census (2011).

The NPT Carers Service maintains a database of carers for their own mailing and other purposes, and this numbers around 3,400 people.

The West Glamorgan Population Needs Assessment provides data on the social care and health needs of the region.
