- 3. The that Notice of the proposal be published on the 30<sup>th</sup> June 2022, allowing 28 days for receipt of objections. A report to be brought back to Members following the outcome of this period for final determination.

## **Reason for Decisions:**

To enable the Council to comply with the formal publication requirements of the School Organisation Code and associated legislation. Implementation of the proposal will enable the Council to promote high educational standards and the fulfilment of every child's potential. It will also enable the Council to meet its duty to secure efficient education in its area.

# 11. TRAFFIC ORDERS - PROPOSED 30 MPH SPEED LIMIT TRAFFIC REGULATION ORDERS

The proposed traffic regulation orders will convert back the strategic routes to a 30 mph speed limit following the national roll out of the 20 mph default speed limit in order to maintain traffic flow on the principal road network.
