#### **Report of the Chief Finance Officer – Huw Jones**

#### **Matter for Decision:**

#### **Delivery of the Welsh Government's Discretionary Cost of Living Support Scheme – Proposals for use of remaining funding**

#### **Wards Affected: All**

#### **Purpose of report**

To agree the distribution of surplus funds available after the initial delivery of the of the discretionary element of the Welsh Government's cost of living support scheme (COLSS) which was approved by members on the 22<sup>nd</sup> June 2022.

#### **Background**

The Welsh Government announced funding to the 22 Unitary Authorities to provide support payments to households within the County Borough in order to assist with the current cost of living crisis.

The purpose of the funding is to support households across Wales facing an unprecedented cost-of-living crisis, fuelled by soaring energy bills and household living costs.

Welsh Government announced 2 funding streams as follows -

A main scheme – Councils were required to make a £150 payment to all eligible households within council tax bands A – D; and to all households in receipt of council tax support (CTRS) irrespective of band.

This scheme has now closed (5pm on 30<sup>th</sup> September 2022) having supported 54,651 household to the total value of £8,197,650.

A discretionary scheme – For local authorities to provide support for those not included within the criteria for the main scheme. Members approved the initial discretionary scheme criteria on the 22<sup>nd</sup> June 2022 and to date 5,419 people have been paid £150 with a total expenditure of £812,850.

There are approximately 376 still eligible for the payment but yet to apply.

Welsh Government have funded the discretionary scheme to the value of £1,401,836 as estimated spend will be £869,250 there is a surplus of £532,586 that can be used to support individuals in the communities deal with the cost of living crisis.

In light of this it is proposed that the discretionary scheme for Neath Port Talbot be extended to provide additional support as follows:

- Allocate £250,000 to the Discretionary Housing Payment scheme which is used to support tenants struggling to meet their rental costs and costs associated with moving accommodation. The DHP policy is below.
- Allocate £100,000 to local foodbanks to support the community. If at the end of the scheme there is a further underspend additional funding will be provided to food banks.
- There are 1,222 taxpayers that are still resident in NPTCBC who have been identified as eligible for the £150 payment under the main scheme who were required to register for a payment but have not done so by the closing date of the 30<sup>th</sup> September 2022, 5pm.

These residents have received two letters to date and where practical and possible contact has been made by telephone. To prevent residents from missing out on available financial support a final letter encouraging them to apply for the payment will be issued and any resulting applications paid from the discretionary fund.

It is anticipated that of the 1,222 applicants who have not already applied for the main scheme not all will apply hence the over commitment.

The cost of the scheme(s) will be met by Welsh Government.

### **Integrated Impact Assessment**

A first stage impact assessment has been undertaken to assist the Council in discharging its legislative duties (under the Equality Act, the Welsh Language Standards (No.1) Regulations 2015, the Well-being of Future Generations (Wales) Act 2015 and the Environment (Wales) Act 2016. The first stage assessment, attached at Appendix 1 has indicated that a more in-depth assessment is not required.

There will be additional staff resource time required to deal with the administration of the scheme. The admin funding provided will meet this cost.

**Recommendation**

It is recommended that Members:

- Approve the distribution criteria for the remaining balance of the Welsh Government Discretionary Cost of Living Support Scheme
- Grant delegated authority to the Chief Finance Office in conjunction with the leader of Council and the Cabinet member for finance, performance and social justice to determine an appropriate distribution method for funding allocated to foodbanks.

**Reason for proposed decision**

To ensure that all funding available to the Council is utilised in accordance with the terms and conditions of the grant.

**Implementation of decision**

The decision is proposed for implementation after the three day call in period.
