**Initiative description and summary:** The memorial testing policy has been in place since June 2019. This board report makes suitable recommendations and amendments to the policy.

These proposed changes include;

- Temporary safety measures to be extended from 6 months to 12 months.
- Ensure that 2<sup>nd</sup> letters are sent out to grave owners as a reminder of the remedial action that will take place if a memorial is not fitted back to standard.
- Acquire the services of an external contractor to carry out the memorial testing instead of using internal staff.
- Carry out an audit on the memorials that have already been tested and fit those memorials back to the required standard at the expense of the Council.
