The Framework consist of 17 individual Lots, value-banded and geographical / regional Lots for civil engineering works and specialist civils works.

The scope of the Framework includes all civil, structural and highway engineering works.

2. FRAMEWORK DETAILS

Key Performance Indicators

Throughout the Term of the Framework the performance of Contractors in relation to each commission shall be measured against Key Performance Indicators. The Indicators will be used to ensure that works are delivered with due regard to timeliness, quality and budget. Please refer to Volume 2 Schedule 4 of the Framework Agreement.

Community Benefits

Community Benefits are a mandatory requirement in Lots 3 and 4 for projects with a value of £1million or more, and contractors in Lots 3 and 4 will be expected to actively deliver and monitor Community Benefits for these projects.

Additionally, for projects with a value of less than £1 million in all Lots, Community Benefits may be included at each Council's discretion at Call-Off stage (depending on the value and duration), for example, where there is a requirement based on grant funding conditions.

How to use this Framework

Contact your Gateway Manager for access to the Framework documents, including Volume 2 Schedule 6 (Project Allocation) which details the call-off options from the Framework. The following call-off options are available:

- Project Allocation via Schedule of Rates (Lots 2, 6, 7, 8, 9 and 11 only) –
 During the term of the Framework, a mini-competition does not need to
 be undertaken where the Employer deems it appropriate to use the
 Schedule 2b Schedule of Rates to procure a scheme. The Schedule of
 Rates will be considered where the majority of items (i.e. 60% in terms
 of the value of the total of the Prices) in the Schedule of Rates, cover
 the scope of works.
- Direct Award (Lots 2, 5, 6, 7, 8, 9 and 10 only) The Employer may offer a
 direct award project for Emergency Works or other appropriate reason
 approved by the Gateway Manager and in line with objective criteria as
 detailed in Schedule 6.
- Direct Award (Lots 1, 9 and 11 Services only) The Employer may offer a direct award commission for Emergency Works or other appropriate reason approved by the Gateway Manager and in line with objective criteria as detailed in Schedule 6.
- Project Allocation via Mini-Competition This method of allocation will be used where allocation of work according to the Schedule of Rates or a Direct Award is not considered appropriate, when the funding body requires a mini-competition, or where a Term Service Contract is required.
