


For the Quarter 1st April 2023 -30th June 2023 - 50% was achieved. Exceeding the 40% target for this quarter for this target. 2 major applications determined.











Quarter 1 Target for 23/24 is 5 days.

For the Quarter 1st April 2023 - 30th June 2023 - 3.50 was achieved. This measure accounts for fly tipping removed by the authority and for fly tipping removed by the perpetrater as a result of the work undertaken by the waste enforcement team. This figure could be reduced drastically if we were to remove fly tipping immediately after being notified however it would remove the ability of the waste enforcement team to deliver the excellent work that they do to get the perpetrator to remove the waste themselves, and/or to issues Fixed Penalty Notices or prosecute.












The target for this Performance Measure is to maintain or increase number of people helped into work, training or volunteering.

For the Quarter 1st April 2023 -30th June 2023 -29 was achieved. Workways+ delivery, funded by European Social Fund, ended on 31st July 2023 . Participants have continued to be supported by Mentors and Employer Liaison Officers to access training, volunteering and to secure sustainable employment. Figures reflect a positive quarter. The remaining participants have been transferred onto Shared Prosperity Fund Neath Port Talbot Employability – Workways Neath Port Talbot for continued support. Participants will continue to be supported through training, volunteering and employment.





Business Anchor project which will be delivering a range of services to support local businesses. During the first quarter of 2023/24, the team have undertaken a "soft launch" of the project to run alongside the introduction of a new Customer Management System to help effectively track and manage business enquiries.
