# INFORMATION SHARING IN RESPECT OF THE PRACTICE IMPROVEMENT GROUP (PIG)

#### 1. Purpose of Report

The purpose of this report is to share information regarding the work that takes place in the Practice Improvement Group (PIG).

#### 2. Background

The NPT Children and Young People Services (NPTCYPS) Practice Improvement Group is a forum to ensure that representatives at all levels of the Service are able to play a key role in designing, implementing and reviewing the steps taken to improve the delivery of Social Work Services to families in NPT. The group is made up of Principal Officers, Managers, Consultant Social Workers, Deputy Team Managers, Social Workers, Practice Support Workers and Business Support.

## The aims of the group is:

- To ensure that all staff across the Service fully understand where NPTCYPS is currently positioned in relation to the Strategic Improvement Plan. This is to include what has already been achieved and what still needs to be addresses in the future.
- To monitor the impact of the changes implemented and review their effectiveness.
- To Identify and share good practice and disseminating across the Service.
- To learn from Performance Indicators, audits, complaints and feedback.
- To take account of feedback from service users and staff.

- To promote a culture of openness transparency and professional challenge at all levels.
- To ensure that service provision properly meets the need of children & families with Neath Port Talbot and supports social work assessments.
- To link in closely with other groups/meetings in respect of quality practice and learning, to be the driving group for change.
- To ensure that outcome focussed practice continues to be embedded throughout the service.
- To invite guest speakers on good practice to the group.

#### The objectives of the group are:

- To develop an agreed work plan for practice improvement.
- For members of the group to play a full part in sharing, designing and agreeing practice development.
- To ensure the workforce have a voice and are represented and to let them know that their contributions are valued and have influenced the direction of travel.
- To ensure that service provision properly meets the needs of children and families in Neath Port Talbot
