# 15. BUSINESS CASE FOR ESTABLISHING AN IN-HOUSE ADULT FAMILY PLACEMENT SERVICE

#### Decision:

That members grant permission for Officers to make the necessary preparations to bring the Adult Family Placements Service in-house including:

- Serve notice on the current provider ('Ategi') that the Council does not intend to renew its contract after the current arrangement ends on 30th April 2024.
- Engage with Ategi so that potential TUPE arrangements are applied with a view to establishing a Council in-house team.
- Implement a Host payment banding system, including exploring possible budgeted payment uplifts with effect from April 2024.
- Approve delegated authority for the Head of Adult Services to enter into an agreement with Swansea Council to run the service on their behalf.

#### Reasons for Proposed Decision:

To take into account the social care resources available when undertaking an assessment or reassessment of individuals' needs; to ensure a sustainable range of good quality adult social care services are available to meet the needs of the most vulnerable citizens of Neath Port Talbot; to contribute towards the budgetary savings identified in the Council's Financial Plan; and to contribute to Welsh Government's aim to rebalance the social care market by moving services away from for-profit organisations

#### Implementation of Decision:

The decision is proposed for implementation after the three-day call-in period, which ended 9am, Monday 30<sup>th</sup> January, 2024.
